Terms & Condition:

General Terms

1. Papers published as part of a previous degree and prior to registration as PhD student are not eligible for this incentive.
2. Incentive will be paid from the month of acceptance or publication up to January 31, 2026 only. i.e. the last instalment will be for January 2026.
3. Copy of Identity card and other proof of enrolment (attested by the supervisor) as on date and a copy of the paper should be submitted.
4. Monthly incentive of **Rs.12,000/-** will be added to the Non-NET fellowship (Rs. 8,000/-) after publishing the first paper.
5. Monthly incentive of **Rs.5,000/- will be added** to the Non-NET fellowship (Rs. 8000/-) + first incentive (Rs. 12,000/-) after publishing the second paper.
6. The IoE incentive scheme is strictly co-terminus with IoE programme.
7. IoE fellowship incentive **MUST** be duly acknowledged in the publications and the thesis.
